**Motion** by Commissioner Harrison and seconded by Commissioner Eaton to adopt the minutes with correction under roll call that Commissioner Sanderson was present for the meeting. **Motion carried.**

### **ENGINEER/EMA REPORT**

**Motion** by Albert Turner and seconded by Benjamin Eaton to get COVID-19 reimbursement directly from the State instead of FEMA. **Motion carried.**

Bids for the 2006 Travel Trailer purchased from FEMA were presented. Bid amounts were as follows: \$1,300; \$1,150; \$1,800 and \$1,685. **Motion** by Albert Turner and seconded by Brett Harrison to accept the bid for \$1,800 to paid and picked up within 14 days with certified check, cash, or money order. **Motion carried.**

**Motion** by Albert Turner and seconded by Brett Harrison to designate the 2 days as hazard pay starting March 23, 2020 (All workdays employees did not work). **Motion carried.**

Chairman set budget workshop on Thursday May 28, 2020 via zoom.

**Motion** by Albert Turner to offset the ambulance payment from solid waste payments (to the City of Uniontown) via MOU. **Motion died for a lack of second.**

**Motion** by Albert Turner and seconded by Benjamin Eaton to send the MOU to Uniontown regarding offset of payments (for ambulance services). **Motion carried.**

**Motion withdrawn** Brett Harrison by related to payment of 24 hours per week (for payment).
